Training 2024

space2grieve - Developing Bereavement Support Skills.

Dates for the training are as follows and are all based at the ETNA Centre in Twickenham

Introduction/Welcome - Thursday 2 May 7.00pm - 9.00pm

Day 1 Thursday 9 May 9.30am - 4.30pm

Day 2 Thursday 23 May 9.30am - 4.30pm

Day 3 Thursday 6 June 9.30am - 4.30pm

Day 4 Thursday 20 June 9.30am - 4.30pm

Induction - At a date to be arranged to cover all practical aspects of supporting clients.

It is a requirement of the Course that you are able to attend all sessions, including the induction and completing a safeguarding module.

A full training programme will be provided at the Welcome Evening, and will include a mix of both theory and practice, allowing plenty of opportunity for skills development particularly in active listening. There will be some pre and post session tasks for completion and submission, with feedback provided, to support you in your learning. Becoming a volunteer Specialist Bereavement Supporter for space2grieve is dependent upon the successful completion of all the course assignments in accordance with the Trainers assessment criteria.

The cost of the full training is £300 which is non-refundable once the course has commenced. We do recognise that there are circumstances where the cost of training may be prohibitive. Please do inform us of the details so that we can initiate waiving or reducing the training fee in accordance with our Bursary Scheme.
